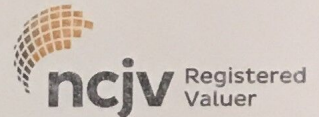

DIAMOND RING

(Stamped K18) 18ct Yellow gold

The pear faceted diamond is two claw one vee claw set flanked by four claw set diamonds in a curved row to one side and having tapered baguette cut and round brilliant cut diamonds claw channel set along the opposing flared and open design shoulder. The slightly round lower shank measures 2.08mm wide at the base and 4.07mm wide at the shoulders. This item is of cast manufacture. Size L. 3.90 grams.

The diamond weights, colour and clarity are estimated, exact measurements could not be obtained due to setting limitations.

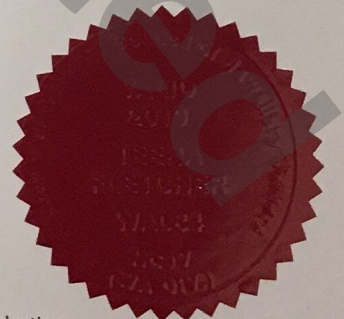
