

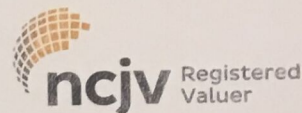

(Stamped 18KT, LOVE VW VERA WANG) 18ct White gold

The cushion cut diamond is heavy four claw set centrally. Diamonds are claw milligrain set forming the halo and claw milligrain set in each under-rail. Sapphires are two claw set in the chenier below and the remaining diamonds are four scalloped claw set in each cross-over style shoulder. The slightly round band measures 3.06mm wide at the base and 3.78mm wide at the shoulders. This item is of mass production cadprint cast manufacture. Size M. 6.23 grams

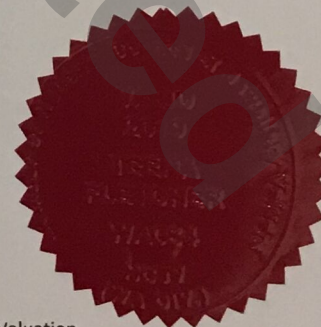
