(Surface acid tested approximately 14ct) 14ct Yellow gold

The larger diamond is four claw set in the centre. Diamonds are micro-caw set in and along the edge of the circular halo and upon each upraised shoulder and along both edges of the under-carriage and shank. The slightly round lower shank measures 1.75mm. This item is of cast manufacture and shows evidence of heavy wear. Size N. 3.34 grams.
