## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct white gold, diamond set, multistone ring, of hand assembled construction.

Plain, narrow, low half round band of 1.92mm width (at base) x 1.16mm depth, with hollow shoulders, and a curved underrail.

Feature three central 'v' shaped settings, each housing one Princess cut diamond, largest to the centre, and end set. The central settings are secured to the underrail and in between the extended and square shoulders. Each of the shoulders house three Princess cut diamonds, slightly graduating in size, and channel set.

Polished finish.

Stamped '18k michael hill 0.75' - acid tested as 18 carat gold.

Ring size: L 3/4.

The ring contains:

Nine end set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 1.60mm(L) x 1.60mm(W) x 1.14mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.64mm(L) x 3.40mm(W) x 2.41mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 3.99 grams Total Gemstone Weight = 0.75ct Total Metal Weight = 3.84 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
