Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, diamond set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.71mm width (at base) x 1.28mm depth, with hollow top and should me, open back settings, and a curved underrail.

Feature central raised cushion shaped top plate, housing twenty-five single cut diamonds, bead set. Surrounding is one row of twenty-eight single cut diamonds, bead set. The top plate is secured between the slightly tapering shoulders. Each shoulder houses seven single cut diamonds, graduating in size and bead set. Rhodium plating to the settings areas.



Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

Sixty Seven bead set single cut diamonds, clarity is "Vs & Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 0.70mm (diameter) (smallest)

Dimensions = 1.0mm (diameter) (largest)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 2.76 grams

Total Gemstone Weight = 0.20ct

Total Metal Weight = 2.72 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
