Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of 10ct yellow gold and sterling silver, cushion shaped stud earrings, of hand-assembled construction.

Feature central raised square sterling silver illusion setting, housing one Princess cut diamond, illusion set. Surrounding is one row of twenty single cut diamonds, in a yellow gold top plate, bead set. The top plate is supported with an underrail, and finished with a post and butterfly.

Earring dimensions = 7.87mm (ave. length) x 7.83mm (ave. width) x 4.75mm (ave. depth).

Polished finish.

Stamped '925 10K MHJ' - acid tested as 9 carat gold and sterling silver.

The earrings contain:

Two illusion set Princess cut diamonds, clarity is "Si", colour is "I to J" (mixed).

Dimensions = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.08ct (estimated - see NOTE below)

Forty bead set single cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 0.70mm (diameter) (smallest)

Dimensions = 0.80mm (diameter) (largest)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 1.93 grams Total Gemstone Weight = 0.20ct Total Metal Weight = 1.89 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
