Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand crafted, 9ct yellow gold and rhodium plated, multistone, gem set ring.

Plain, wide, tapered band of 10.33mm at top to 4.94mm in width (at base) x 1.01mm depth, with hollow top and open back (drilled) settings.

Feature four row ring design, housing a total of twenty-eight round brilliant cut diamonds, channel set, with rhodium plating to the setting area.

Polished finish.

Stamped '9ct JP146' - acid tested as 9 carat gold.

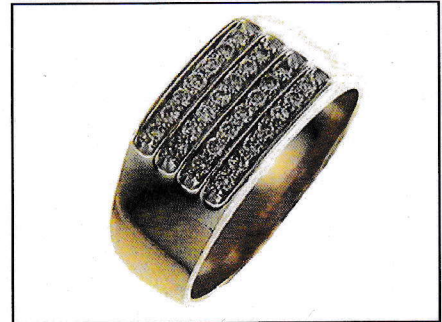
Finger size is Y.

The ring contains:

Twenty Eight channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).
Dimensions (average) = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 7.46 grams
Total Gemstone Weight = 0.36ct
Total Metal Weight = 7.39 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
