## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 9ct yellow gold and 9ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.15mm in width (at base) x 1.16mm depth, with open back settings.

Feature central 'infinity' style design, consisting of seven illusion plates, each housing one round brilliant cut diamond (largest), illusion set. Each side having a single row, illusion set with eight round brilliant cut diamonds, tapering in size, also illusion set. All secured between the shoulders of the yellow gold plain and polished band.



Polished finish.

Stamped '375 JP02' - acid tested as 9 carat gold.

Finger size is O.

The ring contains:

Twenty Three illusion set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I & brown tint' (mixed).

Dimensions = 1.45mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.02mm(Dia) x 1.23mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 3.61 grams

Total Gemstone Weight = 0.40ct

Total Metal Weight = 3.53 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
