Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 18ct white gold, gem set, stud earrings, of hand-assembled construction.

Feature four claw settings, each housing one round brilliant cut HPHT treated natural diamond, claw set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 2.80mm (ave. length) x 2.78mm (ave. width) x 3.22mm (ave. depth).

Polished finish.

Stamped '750(butterflies)' - acid tested as 18 carat gold.

The earrings contain:

Two claw set round brilliant cut HPHT treated natural diamonds, clarity is "Si to P1", colour is "purple pink".

Dimensions = 2.05mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness) (smallest)

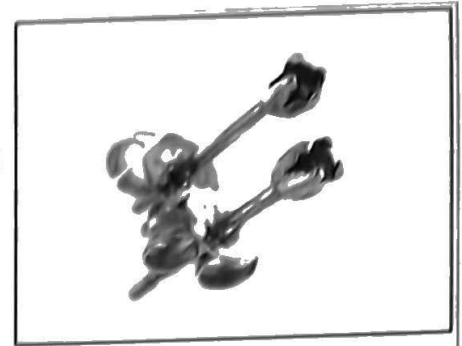
Dimensions = 2.10mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.08ct (estimated - see NOTE below)

Total Item Weight = 0.64 grams

Total Gemstone Weight = 0.08ct

Total Metal Weight = 0.62 grams (estimated)



NOTE: Limited gemmological testing at the Australian Gem Testing Laboratory, inset, indicates the diamonds to be HPHT treated. This treatment is not a natural treatment. Due to setting constraints, the exact dimensions of the HPHT natural diamonds cannot be ascertained. Therefore, weights of the HPHT natural diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the HPHT natural diamonds require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
