Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.45mm width (at base) x 0.97mm depth, with open back settings.

Feature central white gold two claw setting, housing one marquise cut diamond, claw set. The setting is secured to the top of the plain and polished yellow gold, 'V' style band. One of the shoulder terminations houses one row of ten round brilliant cut diamonds, bead set.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set marquise cut diamond, clarity is "Vs", colour is "H".

Dimensions = 7.08mm(L) x 4.05mm(W) x 2.47mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.41ct (estimated - see NOTE below)

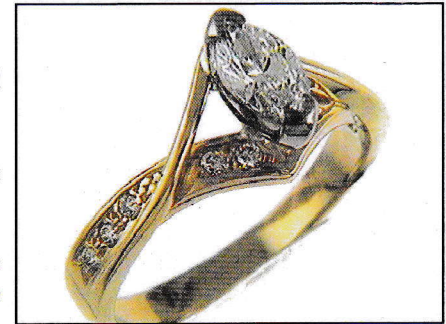
Ten bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.52mm(Dia) x 0.93mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 3.71 grams Total Gemstone Weight = 0.56ct Total Metal Weight = 3.60 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
