Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.96mm width (at base) x 0.91mm depth, with a curved underrail.

Feature central four claw setting, housing one oval natural ruby, claw set. Either side of the central setting, are three shared claw settings, each housing one round brilliant diamond, claw set. The settings are secured between the 'tri-split' style shoulders, of the plain and polished band.

Polished finish.

Unstamped - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One claw set oval shaped natural ruby, colour is "red".

Dimensions = 6.61mm(L) x 5.17mm(W) x 3.15mm(D-estimated)

Total Weight = 0.89ct (estimated - see NOTE below)

Six claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to K" (mixed).

Dimensions (average) = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 3.32 grams Total Gemstone Weight = 1.04ct Total Metal Weight = 3.11 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
