One large diamond is four claw cherner set in the centre and is surrounded by a patterned halo of claw set smaller diamonds and has one diamond bead set each side of the fancy fillagree patterned under-rails and at the end of each side shoulder section. The upraised shoulders are embellished with claw set diamonds and the ring is finished with milligrain detailing. Exact replacement may be difficult.
