

An 18ct, stamped 750 yellow gold one emerald and twelve diamond ring.

The emerald is white gold four claw set in the centre.

Diamonds are white gold five claw collet and white gold four claw collet set in a surrounding row.

The park lane design shoulders are tapered.



1 x Emerald – emerald faceted, 12.4mm x 8.79mm x 6.50mm, estimated weight 5.38ct mid bright green colour, Clarity type III, slightly included 2, contains surface reaching inclusions, chipped along the girdle.

Exact replacement may be difficult, price is pending market availability.

2 x Diamonds - pear cut, 6.1mm x 4.0mm x 2.4mm, estimated weight 0.36ct each, Clarity SI1, Colour F.

2 x Diamonds - oval cut, 5.4mm x 3.6mm x 2.2mm, estimated weight 0.30ct each, Clarity VS1, Colour F.

4 x Diamonds – round brilliant cut, 4.2mm x 4.2mm x 2.5mm, estimated weight 0.28ct each, Clarity SI1, Colour G-H.

4 x Diamonds – round brilliant cut, 3.8mm x 3.8mm x 2.1mm, estimated weight 0.19ct each, Clarity SI1, Colour G-H.
