Six round brilliant cut diamonds are claw set in a centred daisy cluster surrounded by rhodium plate illusion claw set single cut diamonds in the petals of the flower design and are set adjacent to plain posts and are fitted with matching disc butterflies. This item is from the Rosendorff Jewellers, 'Eminence Pinks Collection – Flower Earrings' and are of Argyle origin. Exact replacement may be difficult.
