### Description



A stamped 10K 1.00 Michael Hill white gold seventy seven diamond ring.  
A diamond is eight claw set in the centre with a surrounding row of four claw set diamonds and an outer square halo set with four claw set diamonds.  
A diamond is bead set either side at the base of the setting.  
Diamonds are bead set mill grain edged set along the central row and four claw set along the outer rows, set in the upraised shoulders.

- 4 x Diamonds – round brilliant cut, 2.5mm, estimated weight 0.06ct each, Clarity P2, Colour J-L.
