Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold multistone gem set ring.

Plain and wide, high half round, tapered band of 4.41mm in width (at base) x 1.62mm in depth. Open setting backs with tapering shoulders having curved top outer lips. Feature two tiered top in an oval cluster design having a central, 4-claw, setting housing a single oval shaped and faceted natural blue sapphire. In full outer and lower contoured surround, small bead / claw-set colourless cubic zirconias.



Polished finish Gold stamp not legible - acid tested only.

Finger size = N.

The ring contains:

One claw set oval shaped natural sapphire, colour is "medium dark and patchy blue".
Dimensions = 8.59mm(L) x 6.73mm(W) x 2.97mm(D-estimated) x 10%(Bulge)
Total Weight = 1.53ct (estimated - see NOTE below)

Sixteen claw / bead-set round and faceted, colourless, cubic zirconias.
Dimensions = 1.95mm(Dia) x 1.19mm(D-estimated) x 2%(Bulge)
Total Weight = 0.77ct (estimated - see NOTE below)

Total Item Weight = 11.01 grams - Total Gemstone Weight = 2.30ct - Total Metal Weight = 10.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
