Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 4.60mm in width (at base) x 0.84mm depth, with hollow top and open back settings.

Feature three central raised bezel settings, each housing one oval cut and faceted natural ruby, rub-over set. Surrounded by and having 'swirl' shoulders housing a total of forty-eight round brilliant cut diamonds, tapering in size with the largest four to the centre section, all bead set.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is Z+2.

The ring contains:

Three rub over set mixed cut oval shape natural rubies, colour 'dark red'.

Dimensions = 5.06mm(L) x 4.43mm(W) x 2.50mm(D-estimated)

Total Weight = 1.41ct (estimated - see NOTE below)

Forty Eight bead set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.53ct (estimated - see NOTE below)

Total Item Weight = 8.26 grams - Total Gemstone Weight = 1.94ct - Total Metal Weight = 7.87 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
