## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct yellow gold, dress style, gem set ring, of cast construction.

Plain, narrow, reverse tapered band of 2.30mm in width (at base) x 0.83mm depth, with open back settings.

Feature central four claw setting, housing one oval cut and faceted natural sapphire, claw set. To either side is a three claw setting, each claw set with one round brilliant cut diamond. All secured between the extended and split 'cross-over' and 'wrap-around' style shoulders of the plain and polished band.



Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is K

The ring contains:

One claw set mixed cut oval shape natural sapphire, colour 'dark blue/green'.

Dimensions = 8.50mm(L) x 6.65mm(W) x 3.47mm(D-estimated)

Total Weight = 1.65ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G'.

Dimensions (average) = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 2.77 grams - Total Gemstone Weight = 1.68ct - Total Metal Weight = 2.43 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. Some fine chips and abrasion to the crown facets. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
