Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, platinum & gemstone set, solitaire ring. Plain, narrow, low half round, tapered band, measures 2.41mm width (at base) x 1.16mm depth, with curved underrail, open back setting, underneath.

Feature; "solitaire style" ring design. Comprising, a raised multi claw basket setting, houses one large round, faceted, black 'synthetic moissanite', claw set. The extended shoulders, of the band, tapers up with pointed end terminations, to both sides.

Polished finish, unstamped - acid tested & x-rayed as platinum.

Finger size = J.

The ring contains;

One claw set round synthetic moissanite, colour is "black - opaque" Dimensions = 13.88mm (Diameter) x 6.61mm (D-estimated) Total Weight = 8.18ct (estimated - see NOTE below).

Total Item Weight = 7.59 grams, Total Gemstone Weight = 8.18ct, Total Metal Weight = 5.95 grams (estimated)

Limited gemmological testing inset. The black gemstone may possibly be treated black diamond or treated synthetic black moissanite. Limited testing, whilst set, cannot determine the nature of these gemstones. Therefore, the black gemstone, would require removal from its setting for full and accurate gemmological testing. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
