Valuation for Traditional Retail Insurance Replacement

Item 1

One, gents, hand finished, raised 9ct yellow gold & diamond set, multistone ring. Plain, wide, low half round, tapered band, measures 4.49mm width (at base) x 1.32mm depth, with cut-out underrail, open back settings, underneath.

Feature, "dress style" ring design. Comprising, a rectangular-shaped top, with four channel rows across the top, houses twenty eight round brilliant cut diamonds, channel set. The extended shoulders, of the band tapers up wide to the top, from both sides.

Polished finish, stamped "417 michael hill, 1.00TDW" - acid tested approximately 10 carat gold.

Finger size = U.

The ring contains;

Twenty Eight channel set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.05mm (average diameter) x 1.25mm (D-estimated) (smallest)

Dimensions = 2.22mm (average diameter) x 1.35mm (D-estimated) (largest)

Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 8.21 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 8.01 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
