## Valuation for Traditional Retail Insurance Replacement

## Item 1

One pair of, 9ct white gold earrings, diamond set, multistone, 'cluster' style earrings of handassembled construction.

Feature round raised top plate, housing seventeen round brilliant cut diamonds, largest alternating with medium size diamonds, and smallest to the centre, claw set. Surrounding is one row of twenty-four round brilliant cut diamonds, claw set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 10.95mm (ave. length) x 10.94mm (ave. width) x 5.14mm (ave. depth).

Polished finish. Stamped '9K TWIIN D0.50CT 750(butterflies)' - acid tested as 9 carat gold.

The earrings contain:

Sixteen claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.64ct (estimated - see NOTE below)

Sixty Six claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "G to J" (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 3.10 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 2.90 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
