## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold & diamond set, three stone ring. Plain, narrow, high half round, tapered band, measures 2.16mm width (at base) x 1.78mm depth, with cut-out underrail, open back settings, underneath.

Feature, "trilogy style" ring design. Comprising, a raised semi rub-over settings, to top in white gold. The extended shoulders, of the yellow gold band tapers up to the top, from both sides.

Polished finish, hallmarked "750, London UK circa 1998" - acid tested as 18 carat gold.

Finger size = J.

The ring contains;

One semi rub-over set round brilliant cut diamond, clarity is "P2", colour is "I", medium cut quality.

Dimensions = 3.45mm (Diameter) x 2.30mm (D-estimated)

Total Weight = 0.17ct (estimated - see NOTE below).

Two semi rub-over set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "I", medium cut quality.

Dimensions = 3.12mm (average diameter) x 1.80mm (D-estimated) (smallest)

Dimensions = 3.17mm (average diameter) x 1.85mm (D-estimated) (largest)

Total Weight = 0.23ct (estimated - see NOTE below).

Total Item Weight = 4.40 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 4.32 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
