## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, raised 9ct yellow gold & gemset, solitaire ring, of cast construction. Plain, narrow, low half round, tapered band, measures 1.46mm width (at base) x 1.55mm depth, with cut-out underrail, open back setting, underneath.

Feature, "solitaire style" design. Comprising, a raised boxed, four claw setting to top. The extended shoulders, taper slightly to the top, from both sides.

Polished finish, stamped "9K" - acid tested as 9 carat gold.

Finger size = J.



The ring contains;

One claw set rectangular, cushion-shaped faceted, synthetic moissanite, colour is "black - opaque".  
Dimensions = 6.10mm (L) x 5.88mm (W) x 5.11mm (D-estimated)  
Total Weight = 1.30ct (estimated - see NOTE below).

Total Item Weight = 2.37 grams, Total Gemstone Weight = 1.30ct, Total Metal Weight = 2.11 grams (estimated)

The black gemstone may possibly be treated black diamond or treated synthetic black moissanite. Limited testing, whilst set, cannot determine the nature of these gemstones. Therefore, the black gemstones require removal from their settings for full and accurate gemmological testing. NOTE: Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
