## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 9ct yellow gold, multistone, gem set ring.

Plain, narrow, tapered band of 2.26mm in width (at base) x 0.71mm depth, with open back (cutout) settings.

Feature five individual multi-claw 'ballerina' style settings, housing five old cut diamonds, largest to the centre, claw set. All secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '9ct' - acid tested as 9 carat gold.

Finger size is Y 1/2.

The ring contains:

Five claw set old cut diamonds, clarity 'Si & P1' (mixed), colour 'I to K' (mixed).

Dimensions = 2.60mm(Dia) x 1.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.95mm(Dia) x 2.09mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 3.16 grams

Total Gemstone Weight = 0.40ct

Total Metal Weight = 3.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
