Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 24.73mm at top to 5.59mm in width (at base) x 0.68mm depth, with hollow top and open back settings.

Feature oval-shape setting, housing ten round brilliant cut diamonds, largest tapering in size to the centre section. Surrounded by fifteen round brilliant cut diamonds (smallest). All diamonds star set.

Polished finish.

Stamped '9CT' - acid tested as 9 carat gold.

Finger size is X 1/2.

The ring contains:

Twenty Five star set round brilliant cut diamonds, clarity 'P1, P2 & P3' (mixed), colour 'H to J' (mixed).

Dimensions = 2.00mm(Dia) x 1.25mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.10mm(Dia) x 1.89mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 10.73 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 10.53 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
