One lady's, raised 18ct white gold & diamond set, solitaire ring. Plain, narrow, half round, tapered band, measures, 2.02mm width (at base) x 1.25mm depth, with curved underrail.

Feature, "solitaire style" ring desing. Comprising, a raised six claw settint to top, houses one round brilliant cut diamond, (laser inscribed & certified), claw set. The extended shoulders, of the band, tapers up to pointed end terminations, to both sides.

Polished finish, stamped "18K, michael hill 305806503" - acid tested as 18 carat gold.

Finger size = L+.

The ring contains;

One claw set round brilliant cut diamond (laser inscribed & certified), clarity is "P1", colour is "H", good cut quality.
Dimensions = 6.11mm - 6.14mm (diameter) x 4.03mm (D-estimated) x 4%(Girdle Thickness)
Total Weight = 1.00ct (estimated - see NOTE below).



Total Item Weight = 3.36 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 3.16 grams (estimated)

The diamond has also been laser inscribed upon the girdle with IGI (logo) and 305806503, michael hill.
