### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct white gold, gem set, 'dress' style ring, of handmade construction.

Plain, wide, low half round, tapered band of 5.10mm width (at base) x 0.98mm depth, with a hollow top and shoulders, and open back settings.

Feature square top plate, with a central bezel setting, housing one natural sapphire, bezel set. The top plate, is secured between the tapering shoulders of the plain and polished band. Each of the shoulders is embellished with a pierced groove in the centre, and two round brilliant cut diamonds, bead set, and a textured finish.

Polished finish.

Unstamped - acid tested as 18 carat gold.

Ring size: V.

The ring contains:

One bezel set oval shaped natural sapphire, colour is "blue".

Dimensions = 8.06mm(L) x 5.89mm(W) x 3.72mm(D-estimated)

Total Weight = 1.48ct (estimated - see NOTE below)

Four bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to K" (mixed).

Dimensions (average) = 1.82mm(Dia) x 1.11mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 9.40 grams Total Gemstone Weight = 1.58ct Total Metal Weight = 9.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
