Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 10ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, flat band of 1.93mm width (at base) x 0.92mm depth, with open back settings, and a curved underrail.

Feature central 10ct gold white gold top plate, with 'flower' style cluster, housing nine round brilliant cut diamonds, largest to the centre, claw set. The top plate is supported with an open wire base, and in between the extended and pointed shoulders, of the plain and polished 18ct yellow gold band.

Polished finish.

Band stamped '750' - acid tested and x-rayed.

Ring size: P.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "I".

Dimensions = 3.45mm(Dia) x 2.10mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Eight claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 1.68mm(Dia) x 1.02mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 2.67 grams Total Gemstone Weight = 0.30ct Total Metal Weight = 2.61 grams (estimated)


NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
