Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of handmade construction.

Plain, narrow, low half round, tapered band of 2.72mm width (at base) x 1.48mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one oval natural sapphire, claw set. Each of the shoulders houses three round brilliant cut diamonds, claw set. The settings are secured between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: S.

The ring contains:

One claw set oval shaped natural sapphire, colour is "pink".

Dimensions = 8.27mm(L) x 6.46mm(W) x 4.88mm(D-estimated)

Total Weight = 2.19ct (estimated - see NOTE below)

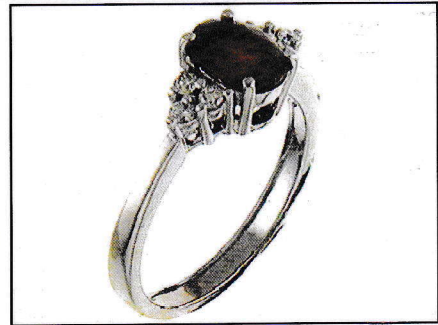
Six claw set round brilliant cut diamonds, clarity is "V s & Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 2.10mm(Dia) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 5.68 grams Total Gemstone Weight = 2.40ct Total Metal Weight = 5.20 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
