Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, and a strand of pearls necklet, of hand-assembled construction.

Feature one strand of fifty-one round cultured pearls, individually knotted. The strand is finished with a yellow gold, oval shaped pearl clasp, embellished with two round natural sapphires, and four round brilliant cut diamonds, all gypsy set.

Necklet dimensions = 38.00cm (ave. length) x 6.50mm (ave. width) x 6.00mm (ave. depth).

Polished finish.

Stamped '9K' - acid tested as 9 carat gold.

The strand contains:

Two gypsy set round natural sapphires, colour is "blue".

Dimensions (average) = 2.00mm(Dia) x 1.22mm(D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below)

Four gypsy set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.03ct (estimated - see NOTE below)

Fifty One knotted round cultured pearls, colour is "cream".

Dimensions = 6.00mm(Dia) (smallest)

Dimensions = 6.50mm(Dia) (largest)

Total Item Weight = 19.30 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
