Valuation for Traditional Retail Insurance Replacement

One pair of, mixed metals, gem set, 'hook' style clip-back pierced drop earrings, of hand-assembled construction.

Feature each earring contains: one cultured baroque pearl, suspended from the yellow mixed metals hook with hinged clip attachments.

Earring dimensions = 50.00mm (ave. length) x 18.26mm (ave. width) x 13.08mm (ave. depth).

Polished finish.

Stamped '14/20 CC' - acid tested and x-rayed as mixed metals.

The earrings contain:

Two drilled baroque cultured pearls, colour is "white".

Dimensions (average) = 43.00mm(L) x 18.00mm(W) x 13.00mm(D)

Total Item Weight = 13.08 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
