Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold multistone ring, of cast construction.

Plain, narrow, low half round band of 1.80mm width (at base) x 1.22mm depth, with a hollow top and shoulders, and open back settings.

Feature one row of nine shared claw settings, spanning across the top of the band, each housing one round brilliant cut diamond, claw set. The settings are secured between the extended and square shoulders, of the plain and polished band.



Polished finish.

Stamped '18k 750T D0.914ct' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

Nine claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G".

Dimensions (average) = 2.94mm(Dia) x 1.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.91ct (estimated - see NOTE below)

Total Item Weight = 2.78 grams
Total Gemstone Weight = 0.91ct
Total Metal Weight = 2.60 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
