Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.39mm width (at base) x 0.73mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature one row of four claw settings, spanning across the top of the band, each housing one round brilliant cut diamond, slightly graduating in size, and claw set. The settings are secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '14K' - acid tested as 14 carat gold.

Ring size: O.

The ring contains:

- Nine claw set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "light brown tint to brown tint".
- Dimensions = 3.02mm(Dia) x 1.84mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 3.37mm(Dia) x 2.06mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 1.52 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 1.32 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
