## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished raised, 9ct rose gold & gemset, dress ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 1.65mm width (at base) x 1.00mm depth, with open back, underneath.

Feature, filigree flower pattern to top, housing one oval-shaped, natural sapphire, claw set. The extended shoulders, of the band tapers, up to the top, with a filigree termination, each side.

Polished finish, stamped "375" - acid tested as 9 carat gold.

Finger size = H.

The ring contains;

One claw set oval-shaped, natural sapphire, colour is "medium dark blue/greenish zone".

Dimensions = 6.48mm (L) x 4.79mm (W) x 3.20mm (D-estimated)

Total Weight = 0.81ct (estimated - see NOTE below).

Total Item Weight = 4.01 grams, Total Gemstone Weight = 0.81ct, Total Metal Weight = 3.85 grams (estimated)

NOTE: Limited gemmological testing, isnet. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
