Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand assembled, 18ct yellow / white gold, multi-stone, ring set, of cast construction.

The set comprising a 18ct yellow gold and 18ct white gold diamond set engagement ring with a fitted and matching 18ct yellow gold diamond set wedding ring. Each ring having a plain, narrow, low half round, tapered band with a combined basal width of 2.49mm x 1.07mm in depth. The engagement ring has a central white gold six claw setting, housing one round brilliant cut diamond, claw set. Either side of the central setting is one, two claw setting housing one marquise cut diamond, claw set. To the top is one row of eleven round brilliant cut diamonds, slightly graduating in size, channel set. There is a point in the centre of the band. The fitted and matching wedding ring has one row of eleven round brilliant cut diamonds, slightly graduating in size, channel set. There is a point in the centre of the band. The wedding ring is secured to the engagement ring above.



Polished finish. Stamped 'illegible stamps' - acid tested as 18 carat gold. Ring size I.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 3.94mm(Dia) x 2.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Two claw set marquise cut diamonds, clarity is "P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 3.75mm(L) x 1.95mm(W) x 1.19mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Twenty Two channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 1.18mm(Dia) x 0.72mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 5.13 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 5.02 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
