Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished raised, 14ct white gold & diamond set, cross pendant.

Feature, drop style, with a fixed bail to the back top, housing, sixteen round brilliant cut diamond, claw set. Open back settings, underneath.

Polished finish, stamped "un-readable" - acid tested as 14ct.

The cross pendant dimensions = 26.00mm (L) x 19.15mm (W) x 2.87mm (D).

The cross pendant contains:

Sixteen claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.37mm (average diameter) x 1.45mm (D-estimated) (smallest)

Dimensions = 2.45mm (average diameter) x 1.49mm (D-estimated) (largest)

Total Weight = 0.80ct (estimated - see NOTE below).

Total Item Weight = 1.50 grams, Total Gemstone Weight = 0.80ct, Total Metal Weight = 1.34 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pendant/cross, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
