Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.10mm width (at base) x 1.19mm depth, with open back settings, and a curved underrail.

Feature cushion shaped top plate, with a central four claw setting, housing one cushion cut diamond, claw set. Surrounding is two rows of round brilliant cut diamonds, claw set. The top plate is secured to the underrail, and in between the tapering shoulders, of the plain and polished band. Each of the shoulders is embellished with round brilliant cut diamonds, graduating in size, and claw set. There a total of forty-eight round brilliant cut diamonds.



Polished finish. Stamped '585 michael hill 1.00' - acid tested as 14 carat gold. Ring size: O.

The ring contains:

One claw set cushion cut diamond, clarity is "P2", colour is "H".

Dimensions = 4.58mm(L) x 4.45mm(W) x 3.02mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.53ct (estimated - see NOTE below)

Forty Eight claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.06mm(Dia) x 1.26mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.47ct (estimated - see NOTE below)

Total Item Weight = 3.70 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
