### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 9ct yellow gold and 9ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.30mm width (at base) x 1.13mm depth, with a hollow top and shoulders, and open back settings.

Feature rectangle white gold top plate, housing one row of four round brilliant cut diamonds, varying slightly in size, and channel set. The top plate is secured between the tapering shoulders, of the plain and polished yellow gold band. The central setting is framed with one groove to the top and bottom of the band, running down the shoulders, and 'strap' style detail.

Polished finish.

Stamped '375 A' - acid tested as 9 carat gold.

Ring size: V.

The ring contains:

Four channel set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 2.40mm(Dia) x 1.46mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.67mm(Dia) x 1.63mm(D-estimated) x 2%(Girdle Thickness) (largest)

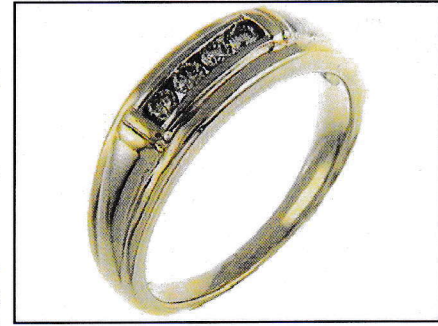
Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 5.14 grams

Total Gemstone Weight = 0.24ct

Total Metal Weight = 5.09 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
