## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.58mm width (at base) x 0.95mm depth, with open back settings, and a curved underrail.

Feature central white gold four claw setting, housing one oval diamond, claw set. Surrounding is one floating row of fourteen round brilliant cut diamonds, claw set. The top plate is secured between the extended and square shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '18K750 C' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One claw set oval shaped diamond, clarity is "Vs2", colour is "F". Dimensions = 6.18mm(L) x 4.45mm(W) x 2.81mm(D-estimated) x 3%(Girdle Thickness) Total Weight = 0.50ct (known weight - see NOTE below)

Fourteen claw set round brilliant cut diamonds, clarity is "Vs", colour is "G". Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.28ct (estimated - see NOTE below)

Total Item Weight = 3.48 grams Total Gemstone Weight = 0.78ct Total Metal Weight = 3.32 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 16444254 Dated: Sep. 17, 2007. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 16444254. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
