Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.92mm width (at base) x 0.99mm depth, with open back settings, and a curved underrail.

Feature central three claw setting, housing one trilliant cut natural amethyst, claw set. Either side of the central setting, is two shared claw settings, each housing one round brilliant cut diamond, claw set. The settings are secured between the tapering decorative shoulders, of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped 'SUPER 14K' - acid tested as 14 carat gold.

Ring size: M.

The ring contains:

One claw set trilliant cut natural amethyst, colour is "purple".

Dimensions = 10.26mm(L) x 9.63mm(W) x 5.95mm(D-estimated)

Total Weight = 2.80ct (estimated - see NOTE below)

Four claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.08ct (estimated - see NOTE below)



Total Item Weight = 6.17 grams Total Gemstone Weight = 2.88ct Total Metal Weight = 5.59 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
