Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 18ct white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.75mm width (at base) x 1.05mm depth, with curved underrail.

Feature, "cluster style" ring design. Comprising a raised four claw setting to top, with peirced out setting, coronet. The extended shoulders, of the band, sweeps up, with pointed end terminations, to both sides.



Polished finish, stamped "750 CG" - acid tested as 18 carat gold.

Finger size = L.

The ring contains;

One bead set round brilliant cut diamond, clarity is "Si, colour is "H", medium cut quality.

Dimensions = 3.75mm (Diameter) x 2.40mm (D-estimated)

Total Weight = 0.21ct (estimated - see NOTE below).

Nine bead set single cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.80mm (average diameter)

Total Weight = 0.23ct estimated

Total Item Weight = 2.89 grams, Total Gemstone Weight = 0.44ct, Total Metal Weight = 2.80 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the germstones cannot be ascertained Therefore, weights of the germstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the germstone require removal from the settings.
