## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand-assembled raised, 18ct yellow and white gold, diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.08mm width (at base) x 1.20mm depth, with curved underrail.

Feature, "cluster style" ring design. Comprising, a flowe style cluster, housing nine round brilliant cut diamonds, claw set in white gold. The extended shoulders, of the yellow gold band, taper up to pointed end terminations, split to each side.

Polished finish, stamped "750, A&C" - acid tested as 18 carat gold. Finger size = H1/2.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "J", medium cut quality.  
Dimensions = 2.85mm (Diameter) x 1.75mm (D-estimated) x 3%(Girdle Thickness)  
Total Weight = 0.09ct (estimated - see NOTE below).

Eight claw set round brilliant cut diamonds, clarity is "Si", colour is "I to K"(mixed), medium cut quality.  
Dimensions = 1.75mm (average diameter) x 1.07mm (D-estimated)  
Total Weight = 0.16ct (estimated - see NOTE below).

Total Item Weight = 3.00 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 2.95 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
