Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 9ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.12mm width (at base) x 1.20mm depth, with cut-out underrail, open back settings, underneath.

Featured, "solitaire style" with shoulder stones. Comprising, a raised four claw setting to top, houses four Princess cut diamonds, grouped, illusion claw set. The extended shoulders, of the band, taper up, ramp style. rhodium polished, each shoulder contains, five round brilliant cut diamonds, channel set, both sides.

Polished finish, stamped "375, AC16" - acid tested as 9 carat gold. Finger size = O.

The ring contains;

Four illusion claw set Princess cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality.

Average dimensions = 2.85mm (L) x 2.85mm (W) x 1.71mm (D-estimated)

Total Weight = 0.49ct (estimated - see NOTE below).

Ten channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 1.90mm (average diameter) x 1.16mm (D-estimated)

Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 4.20 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 4.05 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
