Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 14ct white gold & gemstone set, cluster dress ring. Plain, narrow, low half round, tapered band, measures 1.94mm width (at base) x 1.61mm depth, with curved underrail.

Feature, "cluster style" ring with shoulder stones. Comprising, a raised three claw setting to centre top. Drops to a double row surround. The extended shoulders, of the band tapers up to the top, with 3/4 claw settings to both sides. The undercarriage and side walls, have rub-over setting & claw set (mixed).



Polished finish, stamped "14K michael hill 1.21,4481390015, Star" - acid tested as 14 carat gold. Finger size = K1/2.

The ring contains;

One claw set pear-shaped diamond, (laser inscribed), clarity is "P1", colour is "H", medium cut quality.

Dimensions = 6.60mm (L) x 4.25mm (W) x 2.55mm (D-estimated)

Total Weight = 0.43ct (estimated - see NOTE below).

Ninety Two claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.16mm (average diameter) x 0.71mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 0.75ct (estimated - see NOTE below).

Two rub-over set round pink sapphires, colour is "medium dark -pinkish/red".

Dimensions = 1.50mm (Diameter) x 0.92mm (D-estimated)

Total Weight = 0.03ct (estimated - see NOTE below).

Total Item Weight = 4.10 grams, Total Gemstone Weight = 1.21ct, Total Metal Weight = 3.86 grams (estimated)

NOTE: Limited gemmological testing, inset. No certification was presented or sighted, the pear shaped diamonds is laser inscribed on the girdle "michael hill 44813900115". Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
