## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, hand-assembled raised, platinum & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.74mm width (at base) x 1.27mm depth, with curved underrail.

Feature, "solitaire style" design, with shoulder stones. Comprising, a raised, four claw setting to centre, houses one round brilliant cut diamond, laser inscribed, (on kite facet) claw set. The extended shoulders, of the band, tapers up to the top. Each shoulder contains nine round brilliant cut diamonds tapering sizes, claw set, both sides.



Polished finish, stamped "PT 950" Tiffany & Co 35336702 - acid tested as platinum.

Finger size = H.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Vvs2", colour is "F", excellent cut quality.

Dimensions = 4.59mm - 4.60mm (Diameter) x 2.87mm (D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.37ct (actual - see NOTE below).

Eighteen claw set round brilliant cut diamonds, clarity is "Si", colour is "G & H"(mixed/inset), medium cut quality.

Dimensions = 1.25mm (average diameter) x 0.76mm (D-estimated) (smallest)

Dimensions = 1.75mm (average diameter) x 1.07mm (D-estimated) (largest)

Total Weight = 0.38ct (estimated - see NOTE below).

Total Item Weight = 2.70 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 2.55 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The ring has a stamp of Tiffany & Co upon & is laser inscribed, T & Co P10242562 on one of the kite facets of the central diamond however, Tiffany in Melbourne will not assist with help in authenticating whether or not the ring is of their supply. Therefore, the below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
