Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 3.93mm width (at base) x 0.81mm depth, with open back settings.

Feature central raised four claw setting, housing one oval sapphire, claw set. The setting is secured between the tri-split shoulders, in a 'wrap around' style. Each shoulder has one row of eight round brilliant cut diamonds, bead set.

Polished finish.

Stamped '18ct 750 (partial)' - acid tested 18 carat gold.

Ring size: K.

The ring contains:

One claw set oval shaped natural sapphire, colour is "dark blue green".

Dimensions = 5.05mm(L) x 3.20mm(W) x 1.95mm(D-estimated)

Total Weight = 0.29ct (estimated - see NOTE below)

Sixteen bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 5.40 grams Total Gemstone Weight = 0.54ct Total Metal Weight = 5.29 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
