## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.86mm width (at base) x 1.08mm depth, with open back settings, and a curved underrail.

Feature central four double claw setting, housing one oval garnet, claw set. Surrounding is one row of eighteen round brilliant cut diamonds, claw set. The top plate is upported with an open wire base, and secured between the extended and pointed shoulders, of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

One oval shaped natural garnet, colour is "dark red".

Dimensions = 8.04mm(L) x 5.97mm(W) x 3.64mm(D-estimated)

Total Weight = 1.46ct (estimated - see NOTE below)

Eighteen claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.27ct (estimated - see NOTE below)



Total Item Weight = 2.80 grams Total Gemstone Weight = 1.73ct Total Metal Weight = 2.45 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
