## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 10ct white gold, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.47mm width (at base) x 1.26mm depth, with hollow top and shoulders, open back (cut out) settings, and a curved underrail.

Feature central round raised top plate, housing seven round brilliant cut diamonds, largest to the centre, and claw set. Surrounding is one row of sixteen round brilliant cut diamonds, claw set. The top plate has a pierced decorative gallery, and is secured between the 'ramp' style shoulders. Each of the shoulders houses seven round brilliant cut diamonds, graduating in size and channel set.

Polished finish.

Stamped '10K MHJ' - acid tested as 9 carat gold.

Ring size: J.

The ring contains:

Thirty Seven claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 3.00 grams Total Gemstone Weight = 0.75ct Total Metal Weight = 2.85 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
