Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.28mm width (at base) x 1.31mm depth, with an open back setting.

Feature central white gold six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured between the upswept 'ramp' style shoulders of the plain and polished yellow gold band.

Polished finish.

Stamped '18K michael hill 345818670' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "G".

Dimensions = 6.17mm(L) x 6.11mm(W) x 4.07mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 3.60 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 3.40 grams (estimated)



NOTE: The diamond has been certified by Messrs. International Gemological Institute Certificate number: 34581670. The diamond has also been laser inscribed upon the girdle with IGI (logo) and michael hill and 345818670. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
