## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair of lady's, hand-assembled raised, oval-shaped, 10ct yellow gold & gemstone set, stud earrings.

Feature, "cluster style" earrings. Each comprising, a raised four claw setting, houses one oval-cut, faceted, natural amethyst, claw set. Drops to a surround, containing twenty six single cut diamonds, bead set. Both with plain post & butterfly fittings attached.

Polished finish, stamped "10K MHJ" - acid tested approximately 10 carat gold.

Earrings dimensions = 10.22mm (length) x 8.36mm (width) x 5.81mm (depth).

The earring contains:

Two claw set oval cut, faceted, shaped natural amethysts, colour is "medium dark violet".  
Dimensions = 8.00mm (L) x 6.00mm (W) x 3.66mm (D-estimated)  
Total Weight = 1.90ct (estimated - see NOTE below).

Fifty Two bead set single cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 0.99mm (average diameter)  
Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 2.57 grams, Total Gemstone Weight = 2.16ct, Total Metal Weight = 2.14 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of cluster earrings, ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
